Agenda No. 8. Revision of the membership fees

It was resolved that we may increase the membership fees from Rs. 4,000 to Rs. 5,000. Out of it Rs. 1,000/- will be given to the state/zonal chapters. However, condition will be that the chapter should have its own PAN card, an elected body and organization of annual conference. On submission of the report for the same fund will be released. This revision will be in force from 01/04/2020.

Agenda No. 9 Venue for the Next IAPSM Conference

A proposal to host the next 48th IAPSM conference from AIIMS, Bhubaneshwar, Orissa.

It was approved by GBM.

It was shared that another proposal for the 49th National Conference for year 2022 to be held at Nagpur from GMC, Nagpur was received. It was decided that we shall approve the venue of conference two years earlier so that organizing institute can have enough time for mobilizing funds and organization of the conference. In the light of above decision, it was decided to give approval to the GMC, Nagpur for hosting the 49th National Conference of IAPSM in year 2022.

Agenda: 10. IJCM – Ford Foundation research Grant:

It was decided to rename the Ford foundation research grant to IJCM -Ford foundation research grant with increase of total funds available per year from Rs. 60,000 to Rs, 1,20,000 with additional support of Rs.60,000 from IJCM. It was agreed up on by the Chief Editor IJCM as this fits within the scope of the journal to promote quality research.

Agenda No.11 Financial report by the treasurer and approval of audited report for the Financial year of 2018-19 & budget for the year 2020-21.

Dr. Manish Rana, treasurer IAPSM presented the audited financial report for the year 2019-20 and proposed budget for the year 2020-21.

Dr. Manish Rana, treasurer IAPSM presented the audited financial report for the year 2019-20 and proposed budget for the year 2020-21. Details are as below

- i. IT return for FY 18 – 19 had been completed, for IAPSM and IJCM
- ii. The corpus of IAPSM as on 27 th Jan 2020 is Rs 1,38,63,687 (One crore, thirty eight lakhs, sixty three thousand, six hundred and eighty seven only) of which Rs 75,00,000 (Seventy five lakhs) is invested in debt fund and Rs 63,63,687 (sixty three lakhs, sixty three thousand, six hundred eighty seven) are invested in fixed deposit in State Bank of India.
- iii. For FY 19 – 20 till 31st Dec 2020 the income of IAPSM is Rs. 4527032 and the expenditure is Rs 22,64,836
- iv. The expected income for FY 20 – 21 is Rs. 74,08,184 while the expected expenditure is Rs. 67,40,000
- v. Considering the good financial condition of IJCM, it is concluded that the annual share of IJCM shall be revised from existing 60% to 40% of the interest accrued from IAPSM corpus fund. It will be revised subject to financial status of IJCM.
- vi. The state chapter share of IAPSM is revised to 20% of the interest accrued from IAPSM corpus fund.

- vii. Head Office (support staff, communication, contingency, travel, etc) expenses is revised to Rs. 2,50,000 for each financial year to meet various expenses of head office pertaining to support staff, communication, contingency, travel for meeting, etc.

These revisions in budgetary allocation shall be made from with effect from 1st April 2020 for FY 20-21. It was approved by GBM.

Agenda item No. 12 Report by Chief Editor IJCM

Dr. Pradeep Kumar, Chief Editor, IJCM presented the technical and financial report of IJCM in detail. He sought the approval for the following
