
➤ **IAPSM General Council Meeting on 22 January, 2009**



<b>Governing Council Discussions/Decisions</b>	The Secretary General presented his Report for 2008-2009 including the "Action Taken Report" (ATR) on the minutes of the General Council held in January, 2008. <b>Approved.</b>
<b>General Council Discussions/Decisions</b>	<p><b>Approved.</b></p> <p>The salient features of the Report and the ATR were as under.</p> <p>➤ <b>I. Action Taken Report (ATR)</b>  <i>(The Agenda Number mentioned here in this Section pertains to the Agenda number as mentioned in the Minutes of the General Council held on 24 January 2008):</i></p> <p><b>Agenda 1 to 5:</b> No action was required.</p> <p><b>Agenda 6.</b> The office of the Union Health Minister Dr. Ambumani Ramadoss was contacted atleast 7-8 times by the Secretary General personally through phone/ faxes/ letters for fixing an appointment with him. Regrettably the appointment never came through.</p> <p><b>Agenda 7.</b> A TOT workshop was held out of the RCH grant for the faculty of Community Medicine at NIHF, Munirka, New Delhi in collaboration with NIHF. About 33 faculty members of the Community Medicine (members of the IAPSM) participated in this workshop. Audited accounts of this grant were submitted by Dr. B.S. Garg. The report as well as audited accounts were sent to the Ministry of Health &amp; Family Welfare with a request to release further grant so that state level workshops on "Strengthening Epidemiological and Managerial Skill in RCH" for faculty of Community Medicine can be held.</p> <p><b>Agenda 8.</b> Activities of State Chapters of IAPSM and Sub-Committees of IAPSM: A letter requesting for reactivation of sub-committees was sent out to all sub-committees. An appeal was made to the State Chapters/ Zonal Chapters for organizing various activities. Necessary technical guidance was also provided by the Head Office to streamline their functioning. Many State Chapters have carried out activities since April 2008 to till date. 

Interest was shown by Dr Hemangini K Shah to establish Goa state chapter</p> <p><b>Agenda 9.</b> Respecting the sentiments of the General Council, Dr. Bir Singh , as permanent nominee of CCM, AIIMS to manage the Ford Foundation Grant, made necessary efforts with the Ford Foundation and the faculty members of CCM. Finally, the IAPSM Ford Foundation account maintained in the Indian Overseas Bank, New Delhi has been closed and the entire amount has been transferred to the main account of IAPSM in State Bank of India, Ansari Nagar, New Delhi. A fixed deposit of Rs.10 lakhs has been made out of the total amount received from Indian Overseas Bank.</p> <p><b>Agenda 10:</b> State Chapters and IJCM Head Office to report.</p> <p><b>Agenda 11:</b> The meeting of the Sub-committee head by Dr. V.K. Srivastava was held and fresh guidelines for FIAPSM and Orations of IAPSM have been framed, circulated and accepted. The updated constitution incorporating all amendments till date and the new guidelines for various activities has been finalized and circulated to all Governing Council members and the State Chapters. The updated constitution has also been uploaded on the IAPSM Website.</p> <p><b>Agenda 12.</b> In response to the appeal made by the Head Quarter for updating the database, only 113 out of 2278 members enrolled prior to 1-4-2007 have sent their updated bio-data. As the number of respondents is too small, it was not possible to print a directory.</p> <p><b>Agenda 13.</b> The website of IAPSM has been reconstructed and is now more informative, user friendly, and definitely has better looks. In last seven months or so, this site was visited by about 1400 visitors.</p> <p><b>Agenda 14.</b> Dr. Shamim Haider (Ranchi) has already started preparations for hosting the 2010 IAPSM National Conference.</p> <p><b>Agenda 15.</b> Elections through postal ballot paper was given a trial. However, the results were very discouraging. The Governing Council and General Council need to revisit this item.</p> <p><b>Agenda 16.</b> The Governing Council was quite active throughout the year and had several email discussions on various issues.</p>



<b>Agenda / Issue:</b>	<b>Collaboration &amp; coordination with Indian Public Health Association (IPHA)</b>
<b>Governing Council Discussions/Decisions</b>	Should be strengthened further. <ul style="list-style-type: none"> <li>To avoid clashing of dates of IAPSM and IPHA Conferences, wherever possible joint conferences can be held. If not, the two conferences should be held at least 6-8 weeks apart.</li> <li>Secretary General and the President of IPHA can be invited to the Governing Council as special invitees subject to reciprocation of this gesture by the IPHA.</li> <li>According to the minutes of the IAPSM Conference at Loni, a Joint Action group of IAPSM and IPHA was formed. This can be revived and number of members can be increased.</li> </ul>
<b>General Council Discussions/Decisions</b>	<b>Approved.</b> However, it was decided that the two Special invitees can be the IPHA President / Secretary General or any other members as nominated by the IPHA.

<b>Agenda / Issue:</b>	<b>Endorsement by IAPSM of courses held by Institutions/ Individuals</b>
<b>Governing Council Discussions/Decisions</b>	Use of logo of IAPSM for such courses approved in principle provided the quality of such courses is ensured and there is no financial liability for the Association. Guidelines for such endorsements will be framed by a Sub-committee to be constituted by the Governing Council in 2009-2010.
<b>General Council Discussions/Decisions</b>	<b>Approved.</b> However, in case of externally funded projects/ courses, IAPSM must know the details of funders, their terms and conditions before endorsing the course. In such cases, the proposal should go through the Head office – as was done for the RCH project. Dr B.S.Garg suggested that instead of forming a new committee for scrutinizing such proposals, the existing Sub-Committees should take care of them within the framework of the guidelines that will be framed.

<b>Agenda / Issue:</b>	<b>Elections for 2009-2010</b>
<b>Governing Council Discussions/Decisions</b>	<p>The Secretary General informed that despite notifying the elections through postal ballot in IJCM well in advance, there were only two nominations received for two posts: One nomination for the post of President (Dr. V.K. Srivastava) and one nomination for the post of Member of the Governing Council (Dr. Anmol Gupta). After discussions, the Governing Council decided to elect Dr. V.K. Srivastava as the President of IAPSM for the year 2009-10. Following the constitution of the IAPSM, Dr. A.P. Kulkarni (Aurangabad) will be the Vice President for 2009-10. Dr. Anmol Gupta was elected as the Member of the Governing Council for 2009-10. To fill the other vacant posts in the Governing Council, it was decided to continue with the members of Governing Council 2008-09 provided they had not already completed two consecutive terms and were physically present in the current National Conference or had informed the Secretary General about their absence from the Governing Council meeting. Based on these criteria, three posts were still found vacant. It was decided to request the General Council to nominate three persons to the Governing Council 2009-10.</p>
<b>General Council Discussions/Decisions</b>	<p>Approved. The General council authorized the Secretary General to contact various State Chapters and the fill the remaining three posts.</p> <p><i>(The Secretary General later consulted various State Chapters and filled the remaining three vacancies in the Governing Council.) 
<b>Agenda / Issue:</b>	<b>Election panel for postal ballot 2010</b>
<b>Governing Council Discussions/Decisions</b>	As per constitution of IAPSM, elections will be held through postal ballot for 2010-11. Elections are due for Three Year terms for Head Office of IAPSM and Head Office of IJCM in 2010. To conduct this postal election, an Election Panel was proposed as under.: Dr. Deoki Nandan, Dr. T.S.R. Sai, Dr. R.M. Tripathy Dr. Bir Singh as Secretary General of IAPSM will be assisting this election panel as Convenor. However, if he is a candidate himself for any post, he will not have a voting right in this election panel.

<b>Agenda / Issue:</b>	<b>Travel Grants to post graduate students of Community Medicine and Senior IAPSM Members</b>
<b>Governing Council Discussions/Decisions</b>	Travel grants to Senior IAPSM Members for facilitating their participation in the IAPSM Conference was discussed but not approved. However, travel grants for postgraduate students to attend important courses/ workshops upto a maximum of Rs.5,000/- per candidate was agreed. A maximum of two such grants will be sanctioned per year. The Association can also request the organizers for such courses/ workshops for waiving off such charges for post graduate students.
<b>General Council Discussions/Decisions</b>	<b>Approved.</b> This travel grant should be renamed as "IAPSM Travel Fellowship". The Organizing Secretary of the National Conference of IAPSM may consider exempting the Registration Fee for Senior Members of IAPSM (>65 yrs and retired). Similarly, the registration fee for post graduates students should be kept as low as possible. It was also decided that as far as possible, Travel Fellowship should be awarded on rotation for all zones of IAPSM.

<b>Agenda / Issue:</b>	<b>Proposal for organizing "Public Health Conclave" by Dr. Deoki Nandan at New Delhi in 2009 and simultaneous organization of State Chapters and National Conferences</b>
<b>Governing Council Discussions/Decisions</b>	This idea for the Public Health Conclave as an additional activity was welcomed. However, the issue of canceling IAPSM National Conference in view of this proposed Public Health Conclave was not accepted unanimously by the Governing Council
<b>General Council Discussions/Decisions</b>	<b>Approved.</b> All members were requested to attend this conclave proposed by Dr.Deoki Nandan in large numbers. However, the IAPSM National conferences for 2010 (Ranchi) and 2011 (Berhampur) will be held as scheduled. It was also reiterated that whenever State Chapter Conferences are organized with National Conferences of IAPSM, the State Chapter Conferences should be held before or after the National Conferences days and should not be clubbed with activities of National Conferences.


<b>Agenda / Issue:</b>	<b>Activities of State Chapters and Sub-Committees of IAPSM</b>



<b>Agenda / Issue:</b>	<b>Role of IAPSM Head Office vis a vis IJCM functioning</b>
<b>Governing Council Discussions/Decisions</b>	It was emphasised that IJCM being the mouth of IAPSM has to work within the constitutional framework of IAPSM and hence all information/ notices etc. sent to IJCM by the Head Office of IAPSM should be published without any alternations in the content by IJCM. It was clarified that the Editorial Board of IJCM has complete freedom to ensure quality of the contents published in it. However, any grievance/ complaint expressed by any bonafide member of IAPSM regarding IJCM should be promptly looked into objectively by the IJCM management. The members, if not satisfied, are free to approach Head Office of IAPSM for redressal of their grievance. The Governing Council will take up all such cases on their merit. It was requested that IJCM should have a separate counter during the National Conferences to reply to queries of the members.

<b>Agenda/ Issue:</b>	<b>Concerns of some IAPSM members regarding functioning of IJCM</b>
<b>Governing Council Discussions/Decisions</b>	<p>It was mentioned by Secretary General that he had received complaints from some members of IAPSM who think that their concerns have not been addressed satisfactorily by IJCM Head Office and hence, now they have approached the parent body (IAPSM). This issue was discussed in detail and it was decided that the IAPSM Head Office will write to the Chief Editor to look into the issues raised by these members ( Dr Amarjeet Singh, Dr Rathore and Dr Uday Mohan). The issues raised by Dr Rathore and Dr Uday Mohan are of the routine nature and can be tackled routinely by the IJCM office. On the issue of Dr Amarjeet Singh, the Chief Editor of IJCM is requested to inquire into the issue and inform the Head Office of IAPSM about the same. If the IJCM Chief Editor's inquiry is satisfactory and there is no further need to investigate the matter, the issue will be closed there and then. If there is a need to take any more action on the issue, the Governing Council will decide (through email exchanges &amp; email discussions) the further course of action. The suggestion put forward by the Chief Editor, IJCM for establishing a Redressal Committee to look into this issue was discussed but not accepted by the Governing Council .</p> <p>( Subsequently, the IJCM Chief Editor was requested to enquire into the issue of Dr Amarjeet Singh . He did so and sent his reply to IAPSM Head Office which was shared with the Governing Council members. The Gov Council is satisfied and has decided to close this issue henceforth. It was also pointed out by some Gov Council Members that " it is a good idea to restrict the no of articles published by any one member in 1 year. However the standard of the articles published should not be diluted because of this. The editorial team should be authorized to take the final decisions maintaining transparency. By all means the head office of IAPSM should exert adequate control over its mouth piece and must control any indiscipline by necessary action as and when required").</p>
